

Wheel of Winnings Official Rules

Promotion Period

- 1. Hollywood Gaming at Dayton Raceway will conduct a "Wheel of Winnings" promotion every Monday & Tuesday in March 2024 beginning at 10:00am and ending at 10:00pm each promotion day.
- 2. All times referred to throughout these rules are Eastern Time (ET).

Promotion Eligibility

- 1. Participation is open to all PENN Play members.
- 2. Must be 21 years of age or older to obtain a PENN Play card and participate in this promotion.
- 3. Membership is Free. Patrons may enroll at Player Services.
- 4. A government issued photo ID is required to verify age and identity.
- 5. Participation is limited to activity at Hollywood Gaming at Dayton Raceway.

Prizes

- 1. PENN Play members must qualify for the promotion by earning a minimum of 50 tier points during a promotion day.
- 2. A bonus wheel will be activated for every 50 tier points earned during a promotion day up to a maximum of five (5) times.
- 3. It is the patron's responsibility to play the bonus wheel once earned.
- 4. The U-spin promotion will remain in the player's account until it is played and will expire at the conclusion of each promotion day.
- 5. Un-activated awards will expire at the conclusion each promotion day.
- 6. Prizes range from \$5 \$5,000 PENN Bonus Play.
- 7. PENN Bonus Play will automatically be awarded to patrons PENN Play account.
- 8. PENN Bonus Play of \$499 or less is valid for seven (7) days from the day of award.
- 9. PENN Bonus Play of \$500 or more is valid for thirty (30) days from day of award.
- 10. PENN Bonus Play may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
- 11. Winners are responsible for any applicable federal, state, and local taxes.
- 12. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Dayton Raceway reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Dayton Raceway is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games.
