Promotional Period

- 1. Hollywood Gaming at Dayton Raceway will conduct "Second Chance Drawings" on Wednesdays at 7:00pm beginning January 4th, 2023, until further notice.
- 2. Guest must be a mychoice member.
- 3. Guest must deposit a losing sport bet slip in the drum with name and mychoice number written on the back.
- 4. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

- 1. mychoice members will be notified via direct mail, digital communication, advertising and/or host contact.
- 2. Guest must place wager at Hollywood Gaming Dayton Barstool Sportsbook through kiosk or teller.
- 3. Bet slip must be a losing wager and placed within the last seven (7) days to be valid.
- 4. Guest must legibly write their name and mychoice number on the back of the ticket to be valid.
- 5. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Dayton Raceway reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented.

Prizes & Drawing

- 1. Eligible mychoice member must place their losing wager bet slip in the drum before the 7:00pm drawing time on Wednesdays.
- 2. Drum will always be open for entries except when a drawing is in progress.
- 3. All entries will be emptied from the drum after each weekly drawing.
- 4. Each Wednesday five (5) guests will win \$100 in Promotional VLT Play.
- 5. Guests can only win one time on each drawing day.
- 6. Guests do not need to be present to win.
- 7. All prizes will be awarded to the winner's mychoice account within one (1) hour of being awarded.
- 8. Winners are responsible for all applicable federal, state, and local taxes, as well as title, delivery, and licensing fees.
- 9. Promotional VLT Play Prizes will be valid for seven (7) Days.
- 10. Promotional VLT Play may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
- 11. Promotional VLT Play is valid only at Hollywood Gaming at Dayton Raceway.

In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Dayton Raceway reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented.
