

\$30,000 Love For Free Play Official Rules

Promotional Period

- 1. Hollywood Gaming at Dayton Raceway will conduct a "\$30,000 Love For Free Play" promotion beginning Saturday, February 6, 2021 at 7pm and ending Saturday, February 20, 2021 at 10pm.
- 2. There will be three (3) drawing dates:
 - a. Saturday, February 6, 2021
 - b. Saturday, February 13, 2021
 - c. Saturday, February 20, 2021
- 3. Each date will have drawings occurring at 7pm, 7:30pm, 8pm, 8:30pm, 9pm, 9:30pm & 10pm.
- 4. Up to one-hundred-fifty-six (156) winners will be awarded Free Play during this promotion.

Eligibility

- 1. Must be a member of the mychoice program.
- 2. Must be 21 years of age or older to obtain a mychoice card and participate in this promotion.
- 3. No purchase necessary to receive a mychoice card.
- 4. No play required to be eligible to participate in this promotion.
- 5. A government issued photo ID is required to verify age and identity.
- 6. Participants must have their mychoice card properly inserted into a game at time of drawing to be eligible to win during a drawing.

- 2. mychoice members are randomly selected during the Drawing Periods.

- 5. The "winner" is the person whose name and account number were randomly selected, not the person who was playing using the selected winner's mychoice card (if different than person whose name and account were randomly selected).
- 6. At the end of each drawing all Free Play prizes will be awarded to winner's mychoice account.
- 7. Winners are responsible for any applicable federal, state, and local taxes.
- 8. Free Play Prizes up to \$499 will be valid for 7 Days.
- 9. Free Play Prizes of \$500 and over will be valid for 30 Days.
- 10. Free Play may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
- 11. Free Play is valid only at Hollywood Gaming at Dayton Raceway.
- 12. In the event of a technical malfunction/outage, Hollywood Gaming at Dayton Raceway reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours.
