

\$500,000 Hollywood Dayton Bracket Challenge Official Rules

Promotional Period

- 1. Hollywood Gaming at Dayton Raceway will conduct a "Hollywood Dayton Bracket Challenge" promotion beginning at 12pm, Monday, March 1, 2021 and ending at 11:59pm on Thursday, March 18, 2021.
- 2. A total of one hundred (100) winners will be awarded free play prizes.
- 3. All times referred to throughout these rules are Eastern Time (ET).

<u>Eligibility</u>

- 1. Participation is open to all mychoice members. Membership is free. Patrons may enroll at Player Services.
- 2. Must be 21 years of age or older to obtain a mychoice card and participate in this promotion.
- 3. Participation is limited to activity at Hollywood Gaming at Dayton Raceway.
- 4. A government issued photo ID is required to verify age and identity.

Drawing

- 1. Myhoice members may print a voucher with a unique code and URL from the Hollywood Dayton Bracket Challenge kiosk located near the promotions area.
- 2. Vouchers will be available beginning at 12pm, Monday, March 1, 2021 through 11:59pm Thursday, March 18, 2021.
- 3. Mychoice members will only be able to participate and print one unique code during the time period.
- 4. Vouchers and codes will not be replaced if lost or stolen.
- 5. Mychoice members will be responsible for registering on the website and filling out their selections during the allotted time.
- 6. Entry registration period will begin at 7pm on Sunday, March 14, 2021, and end at 12pm on Friday, March 19, 2021.
- 7. Once a mychoice members bracket selection is made, they are final and cannot be changed.
- 8. At the end of the tournament the top 100 players with the most correct selections will receive free play.

- 9. Prizes will be loaded to the winners' mychoice account by Thursday, April 8th, 2021 at 5pm.
- 10. If a mychoice member correctly picks all 63 games, they will win the insured prize of \$500,000 Cash. Cash prize is insured through Odds on Promotions and paid as a 20-year annuity.

- 15. Free Play may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
- 16. Free Play is valid only at Hollywood Gaming at Dayton Raceway.
- 17. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Dayton Raceway reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Dayton Raceway is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games.
