

Promotional Period

- 1. Hollywood Gaming at Dayton Raceway will conduct a "\$100,000 Big 6" promotion beginning Thursday, May 6, 2021 at 1pm and ending Saturday, May 29, 2021 at 10pm.
- 2. There will be five (5) drawing dates:
 - Thursday, May 6, 2021 1pm, 3pm, 5pm & 7pm
 - Thursday, May 13, 2021 1pm, 3pm, 5pm & 7pm
 - Thursday, May 20, 2021 1pm, 3pm, 5pm & 7pm
 - Thursday, May 27, 2021 1pm, 3pm, 5pm & 7pm
 - Saturday, May 29, 2021 6pm, 8pm & 10pm
- 3. All times referred to throughout these rules are Eastern Time (ET).

Eligibility

- 1. Open to all mychoice members.
- 2. Must be 21 years of age or older to obtain a mychoice card.
- 3. Membership is Free. Patrons may enroll at Player Services.
- 4. No purchase necessary to receive a mychoice card.
- 5. A valid government issued photo ID is required to verify age and identity.
- 6. Participation is limited to activity at Hollywood Gaming at Dayton Raceway.

Implementation

- 1. For one hundred (100) tier points earned from 7AM-6:55PM on each promotional day (7AM-9:55PM on Saturday, May 29, 2021), invited mychoice members are eligible to receive one (1) set of six (6) numbers from the kiosks in the Promotions Area. All mychoice members can earn a maximum of two (2) bonus sets of six (6) numbers on each promotion date. These bonus numbers are only valid on the date the voucher is issued. It is the responsibility of the guest to activate their numbers at the kiosks in the Promotions Area on each promotion date.
- 2. One (1) set of numbers is described as six (6) unique numbers between one (1) and sixty (60).
- 3. Select mychoice members will be eligible to receive one complimentary set of drawing numbers each promotion day.
 - a. Invited mychoice members must swipe at the kiosk beginning at 7am each promotion day to select 6 random numbers, ranging from 1 60.
 - b. Selected numbers will print at kiosk and are only valid the date the voucher is issued.
 - c. Numbers cannot be selected while a drawing is in progress.



- 4. Mychoice members may only select numbers for themselves. Those caught selecting numbers for others will be subject to disqualification and ban.
- 5. The kiosks in the Promotions Area will close five (5) minutes prior to each drawing time. They will be re-opened after each drawing has been completed.
- 6. At each drawing time, a Marketing Representative will draw six (6) balls from the Big Six ball machine.
- 7. The winning numbers will be announced and displayed on select promotion screens throughout the gaming floor.
- 8. Guests can win multiple times during each drawing time and date.
- 8. Participants will have thirty (30) minutes to claim their prize. Guests must swipe their mychoice card at the kiosks in the Promotions Area to claim their prize. Free Play prizes will be issued through the kiosks.
- 9. Mychoice members may only claim prizes for themselves. Those caught claiming prizes for others will be subject to disqualification and ban.
- 10. Free Play Prizes up to \$499 will be valid for 7 Days.
- 11. Free Play Prizes of \$500 and over will be valid for 30 Days.
- 12. Prizes are as follows:
 - Match 2 of 6 balls drawn: \$50 in Free VLT Play.
 - Match 3 of 6 balls drawn: \$200 in Free VLT Play.
 - Match 4 of 6 balls drawn: \$2,000 in Free VLT Play.
 - Match 5 of 6 balls drawn: \$5,000 in Free VLT Play.
 - Match 6 of 6 balls drawn: \$100,000 Cash.
- 13. Only one (1) one-hundred thousand-dollar (\$100,000) prize can be awarded during the promotional period.
- 14. In the event that more than one (1) winning 6 of 6 entry is presented at an individual drawing time, the top prize will be split among the winning entries.
- 15. In the event that one (1) winning 6 of 6 entry is presented throughout the promotion period, the prize for a winning 6 of 6 entry in proceeding drawings in that promotion period will be awarded a tenthousand-dollar (\$10,000) cash prize.
- 16. Time limits will be strictly enforced.
- 17. Free Play may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
- 18. Winners are responsible for all federal, state, and local taxes.



- 19. Entries distributed by the marketing kiosks will have the eligible mychoice number and date/time of distribution clearly on the entry. These Big 6 number sets will only be valid for Big 6 drawings on that promotion day.
- 20. The entries supplied by Hollywood Gaming at Dayton Raceway and the results of the corresponding live ball draw are the sole determinants of whether or not a contestant is a \$100,000 cash prize winner. Entry receipts and printed entries outside of the Marketing Kiosk are used for informational purposes only and will not be considered in determining if a contestant is a prize winner.
- 21. Entries that are mutilated, altered, copied, hand printed, forged, tampered with in any way or that contain printing, mechanical or typographical errors will be considered null & void and will not be eligible for prize redemption.
- 22. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Dayton Raceway reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Dayton Raceway is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management's discretion.

General Rules

- 1. Participants agree to the use of his or her name, city & state and photograph for advertising and promotional purposes without charge or additional compensation.
- 2. Persons on the Penn National Voluntary Exclusion List are not eligible to participate in this program.
- 3. Employees of Hollywood Gaming at Dayton Raceway, its subsidiaries, affiliates, or parent companies are not eligible to participate in this program.
- 4. Immediate family members of Hollywood Gaming at Dayton Raceway employees are not eligible to participate in this program.
- 5. Hollywood Gaming at Dayton Raceway is not responsible for lost or stolen cards, cash, coupons, or lost/misdirected mail.
- 6. Program benefits are not transferable between patrons. Determination will be made at the sole discretion of Hollywood Gaming at Dayton Raceway.
- 7. Hollywood Gaming at Dayton Raceway may disqualify any person based upon fraud, dishonesty, and violation of program rules or other misconduct.



- 8. Hollywood Gaming at Dayton Raceway reserves the right to refuse complimentary redemptions if it is determined that the true cardholder is not present or that coupons or complimentary reward have been changed, altered or tampered with in any way.
- 9. Use of mychoice card indicates acceptance of these Official Rules.
- 10. Any dispute or situation not covered by the above rules will be resolved by Management in a manner deemed by them the fairest to all concerned. That decision shall be final and binding. In addition, Hollywood Gaming at Dayton Raceway reserves the right to change, modify or cancel this program at any time.
- 11. Any change, modification, or cancellation of the program must be approved by the Ohio Lottery Commission prior to the change or cancellation.
