

## Mychoice App Drawings Official Rules

### Promotion Period

- 1. Hollywood Gaming at Dayton Raceway will conduct a random card-in sweepstakes for mychoice members that sign up for, download and display their mychoice mobile application on their cellular device with login in credentials.
- 2. Members must sign up for and register their mychoice rewards account with the mychoice Rewards digital application to receive their prize.
- 3. Drawings will be held Thursdays, June 17 & 24 and July 1, 8, 15, 22 & 29, 2021 at 2pm, 4pm and 6pm.
- 4. A total of two hundred and ten (210) will be selected.
- 5. All times referred to throughout these rules are Eastern Time (ET).

#### <u>Eligibility</u>

- 1. Participation is open to mychoice members that register their existing mychoice rewards account with the mychoice Rewards digital application.
- 2. Membership is Free. Patrons may enroll at Player Services. No purchase necessary.
- 3. Participation is limited to activity at Hollywood Gaming at Dayton Raceway.
- 4. Must be 21 years of age or older to obtain a mychoice card and participate in this promotion.
- 5. A government issued photo ID is required to verify age and identity.

#### Drawing Dates & Prizes

1. Thursdays, June 17 & 24, and July 1, 8, 15, 22 & 29, 2021 at 2pm, 4pm and 6pm.

- 2. Ten (10) mychoice members with their mychoice card properly inserted into a VLT machine will be drawn.
- 3. Upon displaying and verification of photo ID, mychoice card and/or mychoice Rewards application credentials, selected contestants will receive \$100 Free Play.
- 4. In the event a winner is unable to present the necessary credentials, the prize will be forfeited.
- 5. mychoice members may activate their entry inserting their mychoice card into any VLT machine at the time of each drawing.
- 6. Winners must report to the promotions table to claim their prize.
- 7. mychoice members can win a maximum of one (1) time during each drawing.
- 8. All winners must be present and have 4 minutes to claim. Valid photo ID required to claim.

- 9. The "winner" is the person whose name and account number were randomly selected, not the person who was playing using the selected winner's mychoice card (if different than person whose name and account were randomly selected).
- 10. During each scheduled drawing the winning mychoice account number along with the winner's first name and first initial of their last name will be announced on the gaming floor public address system. The same information will also be posted on large projection screens and other monitors throughout the gaming floor.
- 11. All Free Play prizes will be awarded to winner's mychoice account within one (1) hour of being awarded.
- 12. Winners are responsible for all applicable federal, state, and local taxes, as well as title, delivery and licensing fees.
- 13. Free Play Prizes up to \$499 will be valid for 7 Days.
- 14. Free Play Prizes of \$500 and over will be valid for 30 Days.
- 15. Free Play may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
- 16. Free Play is valid only at Hollywood Gaming at Dayton Raceway.
- 17. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Dayton Raceway reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Dayton Raceway is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management's discretion.

### **General Rules**

- 6. Program benefits are not transferable between patrons. Determination will be made at the sole discretion of Hollywood Gaming at Dayton Raceway.
- 7. Hollywood Gaming at Dayton Raceway may disqualify any person based upon fraud, dishonesty, and violation of program rules or other misconduct.

- 8. Hollywood Gaming at Dayton Raceway reserves the right to refuse complimentary redemptions if it is determined that the true cardholder is not present or that coupons or complimentary reward have been changed, altered or tampered with in any way.
- 9. Use of the mychoice card indicates acceptance of these Official Rules.
- 10. Any dispute or situation not covered by the above rules will be resolved by Management in a manner deemed by them the fairest to all concerned. That decision shall be final and binding. In addition, Hollywood Gaming at Dayton Raceway reserves the right to change, modify or cancel this program at any time.
- 11. Any change, modification or cancellation of the program must be approved by the Ohio Lottery Commission prior to the change or cancellation.
