

## **Promotional Period**

- 1. Hollywood Gaming at Dayton Raceway will conduct a "Get Five to Stay Alive" promotion beginning at 5:00am, Monday, August 1, 2022, and ending at 10:00pm on Friday, August 26, 2022.
- 2. A total of eighty-four (84) winners will be selected.
- 3. All times referred to throughout these rules are Eastern Time (ET).

#### Eligibility

- 1. Participation is open to all mychoice members. Membership is free. Patrons may enroll at Player Services.
- 2. Must be 21 years of age or older to obtain a mychoice card and participate in this promotion.
- 3. Participation is limited to activity at Hollywood Gaming at Dayton Raceway.
- 4. A government issued photo ID is required to verify age and identity.

## **Drawing Dates & Prizes**

- 1. Fridays, August 5, 12, 19, & 26, 2022 at 7:00pm, 7:30pm, 8:00pm, 8:30pm, 9:00pm, 9:30pm & 10:00pm.
- 2. Three (3) mychoice members will be selected each drawing to play the "Get Five to Stay Alive" game to determine their prize.
- 3. Get Five to Stay Alive Game
  - o There will be three (3) sets of five cards displayed face down on the board.
  - o Each contestant will be assigned a set of cards according to the order in which they claim.
    - First claimed will be the top row of cards, second claimed will be the middle row of cards and the third claimed will be the bottom row of cards.
  - The first card in each contestant's row will be revealed.
  - o Each contestant will choose whether the next card in their row is higher or lower.
  - o If the contestant chooses correctly, they will advance and have the option to keep the free play prize assigned to the card column they advanced to or continue playing the game and choose if the next card will be higher or lower. If a contestant chooses to move to the next round and chooses incorrectly, the contestant will receive the free play value assigned to the first card column (\$100 Free Play). This will continue until the contestant chooses to keep the free play prize they reach, chooses incorrectly, or reaches the last card in their row.
  - o In the event the next card is the same, neither higher nor lower, that will be considered as the contestant choosing correctly.
- 4. Free Play prizes are as follows:
  - First Card \$100 Free Play
  - Second Card \$200 Free Play
  - Third Card \$300 Free Play
  - Fourth Card \$400 Free Play
  - o Fifth Card \$500 Free Play



- 5. Winners that show proof of an established mywallet on their mychoice app will have their Free Play prize doubled.
- 6. mychoice members may activate their entries either through the promotional kiosks or by inserting their mychoice card into any VLT machine beginning at one hour prior to each drawing.
- 7. Winners must report to the promotions table to claim their spot.
- 8. Up to two (2) re-draws will occur for each unclaimed prize before it is forfeited.
- 9. Members can win a maximum of one (1) time per drawing day.
- 10. All winners must be present and have 4 minutes to claim. Valid photo ID required to claim.
- 11. Winner's names will be announced and posted on select display screens throughout the gaming floor. In the event of any AV or display failure it will be the guest's responsibility to check the posted names at the promotions area.
- 12. All Free Play prizes will be awarded to winner's mychoice account within one (1) hour of being awarded.
- 13. Winners are responsible for all applicable federal, state, and local taxes, as well as title, delivery, and licensing fees.
- 14. Free Play Prizes up to \$499 will be valid for seven (7) Days.
- 15. Free Play Prizes of \$500 and over will be valid for thirty (30) Days.
- 16. Free Play may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
- 17. Free Play is valid only at Hollywood Gaming at Dayton Raceway.
- 18. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Dayton Raceway reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Dayton Raceway is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management's discretion.

## **Earning Entries**

- mychoice members will receive one (1) free entry.
- 3. For every 1 tier points earned through play, members will earn one (1) entry.
- 4. Additional earned entry days, multipliers or bonus entries may be offered via direct mail or e-blast offerings to invited mychoice members.
- 5. Entries are earned off base tier points only. Any bonus tier points earned through a promotion will not be eligible for entries.
- 6. Entries will roll-over after each drawing. All entries will expire following the conclusion of the final drawing of the promotion.



# **Entry Activation**

- 1. Participants must activate their entries anytime between 6:00 PM and 9:59 PM to be eligible to win.
- 2. mychoice members may activate their entries either through the promotional kiosks or by inserting their mychoice card into any VLT machine beginning at one hour prior to each drawing.

- 8. Hollywood Gaming at Dayton Raceway reserves the right to refuse complimentary redemptions if it is determined that the true cardholder is not present or that coupons or complimentary reward have been changed, altered, or tampered with in any way.

- 10. Any dispute or situation not covered by the above rules will be resolved by Management in a manner deemed by them the fairest to all concerned. That decision shall be final and binding.
