



New Member Official Rules

Promotion Period

1. Hollywood Gaming at Dayton Raceway will conduct a "New Member" promotion beginning Sunday, January 1, 2023, and will run until further notice.
2. All times referred to throughout these rules are Eastern Time (ET).

Eligibility

1. New members that join the mychoice program are eligible to participate in this promotion.
2. New member is defined as a patron that has never been a member of the Hollywood Gaming Dayton Rewards program.
3. Guests must visit kiosk at Hollywood Gaming at Dayton Raceway within five (5) days of registering as a new member to be eligible to participate.
4. Membership is Free. Patrons may enroll at Player Services. No purchase necessary.
5. Participation is limited to activity at Hollywood Gaming at Dayton Raceway.
6. Must be 21 years of age or older to obtain a player's club card and participate in this promotion.
7. A government issued photo ID is required to verify age and identity.

Prizes

1. Promotion will be available upon enrollment and may be activated by swiping mychoice card at any promotional kiosk.
2. Patron must swipe at kiosk, enter their pin, and select the New Member promotion.
3. Patron will spin the wheel to receive their prize.
4. Prizes range from \$10 - \$1,000 Free Play.
5. Free Play will automatically award to patron's account.
6. All Free Play rewards is valid for one (1) day from day of award.
7. Free Play may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
8. Winners are responsible for any applicable federal, state, and local taxes.
9. Free Play offers only valid at Hollywood Gaming at Dayton Raceway.
10. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Dayton Raceway reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Dayton Raceway is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management's discretion.



New Member Official Rules

General Rules
