

Promotional Period

- 1. Hollywood Gaming at Dayton Raceway will conduct "Gift Giveaways" on Tuesdays, March 7, 14, 21 & 28, 2023 from 3:00pm to 7:00pm.
- 2. Giveaway Dates:
 - Tuesday, March 7th Bamboo Melamine Set of Six (6) Salad Plates
 - Tuesday, March 14th Bamboo Melamine Set of Six (6) Bowls
 - Tuesday, March 21st Bamboo Melamine Set of Six (6) Dinner Plates
 - Tuesday, March 28th Bamboo Melamine Three (3) Serving Trays
 - * Items may be distributed in alternate order or substituted due to shipping/supply chain issues
- 3. Invited guests can begin swiping their mychoice card at marketing kiosks at 7:00am to receive their redemption voucher. Guests can redeem their voucher by picking up their giveaway item at the designated giveaway area between 3:00pm and 7:00pm.
- 4. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

- 1. Invited mychoice members will be notified via direct mail, digital communication and/or host contact.
- 2. Invited The Owners Club Members will receive two (2) gifts.
- 3. mychoice members that do not receive invite for complimentary gift can qualify for one (1) gift by earning two hundred (200) tier points through play from 5:00am to 6:59pm on the day of the promotion.
- 4. Invited mychoice members also can earn one (1) additional gift by earning two hundred (200) tier points through play from 5:00am to 6:59pm on the day of the promotion.
- 5. Earn one (1) tier point for every \$5 of coin-in.
- 6. Only the guest whose name appears on the gift voucher will be able to pick up their gift(s). Guests must present their valid government issued photo I.D. and kiosk voucher to pick up gift.
- 7. Gifts will be available while supplies last.
- 8. Approximately one thousand five hundred (1,500) gifts are available on the promotion day.
- 9. If Hollywood Gaming at Dayton Raceway runs out of gifts, Free VLT Play will not be administered as the result of running out of the specified gift. Hollywood Gaming Dayton mgmt. does reserve the right to offer another gift of similar value to the guest if all advertised gifts are allocated. This determination will be made by Hollywood Gaming at Dayton Raceway.
